Arthur Vincent Higgins

The Return to Ohio

Following his term of office as provincial, Higgins returned briefly to New Haven and then to New York. In 1899, he was assigned to St. Patrick's in Columbus and remained a year. He returned to St. Mary's in New Haven, receiving the appointment of pastor and religious superior.

Because of growing health problems, he resigned the New Haven position and in 1902, he once again returned to St. Patrick's on Grant Avenue in Columbus. Here he stayed for five years. During this time, Higgins undertook the parochial duties of St. Patrick's parish and also served in the position of chaplain to the Sisters of the Holy Cross at Mt. Carmel Hospital in the near west side.

Higgins was assigned to St. Patrick's during the time of the founding of St. Patrick's College by Father Kearney in 1905; this institution later became Aquinas College High School. The records available are silent about any involvement Higgins might have had in the early days in Columbus of this new Dominican venture

into secular education. Given his own student days at St. Joseph College near Somerset, one would suspect that Higgins supported the establishment of this new educational institution. Possibly he was too infirm at this time to enter wholeheartedly into this new establishment sponsored by his friend and former secretary, Kearney. Nonetheless, Coffey, in quoting the Memoirs of Father Richard Meaney, the priestcontractor who build both the House of Studies in Washington and the original building for St. Patrick's College, notes that Higgins was present at an informal meeting in Washington in January, 1905, with Bishop Hartley.14 At this gathering, the Dominicans present suggested to Hartley, who had come east in search of a Religious Order to found his desperately needed secondary school for young men, that he meet with the then provincial, Father Kearney, in Zanesville, to secure if possible Dominican involvement and support for this educational project. Of course, Kearney and Hartley did work together in the founding and establishment of what was the first venture of the Dominicans into secular education since the closing of St. Joseph College, Higgins's alma mater, in 1861.

O'Daniel notes that Higgins's health had not been good for some time. In 1907, he became so ill that he was sent to St. Joseph's near Somerset so he could rest in the country environment. It is unclear what the exact nature of his infirmities were early on, but eventually he endured the debilitating disease of hardening of the cerebral arteries. This malady, O'Daniel suggests, severely affected his brain. From the perspective of seventy-five years later, one suspects that Higgins may have been suffering from what today one would diagnose as Alzheimer's disease. Undergoing extreme debilitation from the hardening of the cerebral arteries, Higgins was sent eventually to the hospital run by the Alexian Brothers in St. Louis. This St. Louis hospital had a special section dedicated to patients with severe mental and psychological problems. There he lingered for several years. Father Higgins died on Easter Sunday, April 8, 1917.15

Father Higgins's body was returned to St. Joseph's Priory where the funeral Mass and burial liturgy were celebrated on Thursday, April 12, 1917. His long time friend and former provincial secretary, Father Kearney, delivered the eulogy. Along with Kearney, two other clerics who had been novices under the watchful eye of Father Higgins during his days as novice-master at St. Joseph's, Fathers D. J. Kennedy and J.E. Kernan, were celebrants of the solemn requiem Mass. Both Kennedy and Kearney received the degree of Master of Sacred Theology and became leading lights among the American Dominicans. At this time, Kernan was pastor of St. Patrick's Church in Columbus.

Higgins was buried in the community cemetery of St. Joseph's within ten miles of his birthplace at the family home on the Somerset Road just north of New Lexington.

All of the documents and texts read in preparation of this biographical essay speak eloquently about the very high degree of native intelligence with which Higgins was endowed. The term "brilliant" is used over and over. O'Daniel writes the following:

He had one of the brightest minds in the country. This he stored with knowledge of all kinds by constant reading and study until he became a walking encyclopedia, and could hold his own even with specialists in various fields.¹⁶

In his account of the first two Dominican priories in the United States, O'Daniel writes in a similar vein:

Of a studious temperament and possessed of a brilliant mind, he became one of the outstanding priests of the country--a profound philosophers and theologian, as well as an excellent linguist.¹⁷

The Columbian obituary contains the following remarks about the depth of Higgins's learning: "Of a kindly, quiet disposition, Father Higgins, in his days of health, possessed one of the most wonderful and brilliant minds in the Dominican Order." Even Coffey, who is quite critical of Higgins's lack of administrative skills, lauds continuously his intellectual skills.

The *Dominicana* obituary reiterates these claims about Higgins's rich and vast intellectual acumen:

Endowed with genius of intellect and a singularly retentive memory, Fr. Higgins stands out as a giant in the intellectual life of the Dominicans of the United States. He was everywhere recognized as one of the best philosophers and theologians in the country. One of the most eminent theologians in the country today,

is authority for the statement that he never met in this land or in the Old World, a man with such a breadth and profundity of learning.¹⁹

Different accounts also speak of the depth of Higgins's knowledge in classical language and literature. O'Daniel notes that when Higgins met the then Master General of the Dominicans, Andrew Francis Fruhwirth, in Rome, Fruhwirth and his Roman staff marvelled at Higgins's command of Latin and Greek, especially for "one wholly educated in America."

Underneath this vast intellectual depth seems to have rested a quiet and amiable personality well liked by many persons. His mid-western roots going back to the rolling hills of Perry County appear to have kept Higgins a humble and likeable person throughout his life.

Yet given all of this raw intellectual power, one looks in vain for evidence of that native genius to which all of the written documents attest. Where are the books, the articles in philosophy and theology, the other written materials which would serve to justify this claims? Nothing seems to exist. This is indeed unfortunate. One gets the impression that Higgins indeed published little or nothing. If this indeed were the case, then this is a sad commentary on the state of the intellectual life of the American Dominicans during the final three decades of the nineteenth century. In reading between the lines, it is almost as if the Dominicans did not know what to do with a person with these phenomenal intellectual talents. There were no colleges or university appointments for Higgins to assume.

It appears that Higgins's active intellectual life all but ceased once his term of provincial had ended. He was then not yet fifty years old, but he appears to have been, at that time, an exhausted person needing rest and recuperation. From 1897 on, Higgins becomes for the most part an assistant parish priest, and, as noted above, during his stay

in Columbus, the chaplain at Mt. Carmel Hospital. It is almost as if Higgins were physically and mentally burnt out following his term as provincial. Possibly his health problems, which forced his extended hospitalization later in St. Louis, were already beginning to take their toll. One does not know from reading the documents alone.

This brings to a close the fascinating story of a native son of the Diocese of Columbus, a child prodigy, a student of the classics, a thoughtful theologian, and a Dominican priest who served many years of his priestly life within the confines of the diocese of his birth

ENDNOTES

Sources for this biographical study of Father Higgins are principally the written histories of the American Dominicans by Reginald Coffey and Victor F. O'Daniel. In addition, the author consulted the microfilm of *The Catholic Columbian* located in the library of Ohio Dominican College. The bound volumes of *The Dominicana*, from which came an obituary of Higgins, are located in the library of the Josephinum College.

Another person important in the development of the intellectual life of American Catholicism in the second half of the nineteenth century, John Augustine Zahm, was also born in the New Lexington area about the same time as Higgins. Born on June 14, 1851, Zahm attended the University of Notre Dame, became a member of the Congregation of the Holy Cross and eventually their United States Provincial, and served on the faculty of Notre Dame. He died in 1921. Both from New Lexington, Higgins's and Zahm's life spans overlap almost completely.

For a more detailed account, the reader may consult the author's A History of Aquinas College High School, published by the Society in 1984.

15. O'Daniel lists April 10 as the day of Father Higgins's death; cf. p. 469. Yet the Dominicana and the Columbian obituaries note that he died on Easter Sunday, 1917. Easter was on April 8 that year. Both obituaries give Thursday, April 12 as the day of burial from St. Joseph's Priory. Of course, this dating would make April 8 the Sunday of that week. While O'Daniel is usually correct on dates and places, it appears that the April 10 date is mistaken. O'Daniel repeats this date in his narrative on St. Joseph's Priory, The First Two Dominican Priories in the United States.

Universal Church

Feb. 22 The Holy Father, Pope John Paul II, released his *Letter to Families*, a study of the fundamental aspects of the family and marriage, "the heart of the civilization of love."

April The Sacred Congregation for Divine Worship and the Discipline of the Sacraments approved service at the altar by women, upon the approval of that interpretation of Canon Law by Pope John Paul II.

May 22 The Holy Father released *Ordinatio* Sacerdotalis, reaffirming the teaching of the impossibility of ordaining women to the priesthood.

Sept. At the United Nations' International Conference on Population and Development, the Papal emissaries defeated a proposition that would have encouraged abortion throughout the world.

Oct. 2 The Synod of Bishops on the religious life was opened by Pope John Paul II.

Oct. 30 The Vatican announced the appointments of thirty new cardinals, to be installed Nov. 26, bringing the number of appointments by the present pontiff to 100 of the 120 who are under age 80.

Nov. 14 The Vatican released Pope John Paul II's apostolic letter *Tertio Millennio Adveniente*, anticipating the 2,000th anniversary of the birth of Jesus Christ; announcing a jubilee or holy year in 2000; and setting out a program of preparation for the event.

Feb. 20 Ground was broken for the Holmes County Catholic Center, on the grounds of Millersburg St. Peter Parish, for that parish and Glenmont Sts. Peter and Paul. It was dedicated by Bishop Griffin on September 11.

June 12 The Sisters of Divine Providence withdrew from Dover St. Joseph parish, where the order had served since 1886.

Dec. 10 A new parish center at Columbus St. Agatha Parish was dedicated by Bishop Griffin.

Dec. Bishop Griffin approved a program of parish administration by a lay or religious (non-priest) administrator for Columbus St. Stephen the Martyr Parish, to begin July 11,1995.
